What Happened?

CBSE has announced New affiliation Bye-laws on 18th Oct'18.

Who does it impact?

All CBSE schools requiring new affiliations or upgrading existing affiliations or seeking extension of existing affiliations.

What has changed?

Among other changes, the most significant procedural change is the requirement of two mandatory inspections as against the earlier practice of only one.

Under the new Bye-laws, First inspection is to be carried out by the respective state government officials covering land and land related documents, infrastructure, and statutory compliance in the areas of fire safety, building safety, health and hygiene. While a Second inspection is to be performed by a CBSE appointed inspection committee to assess areas like academics, teacher student ratio, facilities provided for the promotion of sports education etc.,

Is there a timeline for compliance?

Yes, the last date of applying for the above said activities is 31st March 2019 for academic year 2020-21 (earlier 30th June).

How can schools ensure compliance?

Dr. APJ Educational Consultancy has come out with a solution, **CQ Audit**, to help the school management perform a complete 360 degree evaluation on compliance to CBSE affiliation bye-laws.

What does the CQ Audit comprise?
